- 1. Call to Order by David Ikeda and agenda adopted at 19:15
- 2. Yuka Sato-Atiyota was appointed as recording secretary. A motioned by David Ikeda, seconded by Aaron Mollin, approved unanimously.
- 3. Review and adoption of Minutes of the 2019 Annual General Meeting (AGM). A motion (M) by Yuko Sorano, seconded by (S) Susan Kim, passed unanimously.
 - David Ikeda welcomed members and guests. David Ikeda announced his resignation from the president role as well as board member position in this coming year, after new president is elected.

- 4. Update from the board of directors
 - Overview

Tomoko Fukushima provided board update overview. See attached slide. Resignation of Michelle Chibba, Terry Ikeda, Meaghan Tanaka, and Kento Ikebata during the past year was reported. Fukushima also introduced Aaron Mollin and Yoko Reynolds as new board members joined since the 2019 AGM. Tokugi Suyama's resignation as a regular board member and appointment as an honorary member were announced. Suyama's contribution to JSS was recognized and celebrated. A certificated and flower were presented to Tokugi Suyama, by former board member Kiyoshi Dembo who was attending the AGM with him.

- Pandemic response Remote services and IT update Yoko Reynolds reported JSS's COVID-19 pandemic response and provided update on remote services. See attached slide.
- Strategic planning Yuko Sorano reported an update regarding the agency's strategic planning. JSS board and staff are currently working on its strategic planning. See attached.

David Ikeda reported that an auditors' report is unavailable for review due to a process delay caused by the COIVD-19 pandemic. David Ikeda presented unaudited Financial statements as attached. Cutbacks in part-time staff hours persist. Generous donors and founders were acknowledged for their continuing supports.

Motion to appoint Kakuma & Ratner Chartered Accountants as auditor for 2020 fiscal year by David Ikeda; approved unanimously.



Report from the Board of Directors

Holiday Drive (December 2020)

- Holiday Drive adapted to the Covid restrictions through collecting cash donations and purchasing of gift to families in need
- Despite the lack of physical donation boxes in our networks, we received warm support from so many
- Served 28 families, consisting on 72 individuals of all ages

JSS Challenge (June 2021)

- Virtual walk/run that took place on June 13, 2021
- Overwhelming support in terms of participant attendance (33 individuals collectively running/walking 166.51km) and donations totaling \$19,195
- Last but not least, the JSS Challenge was born out of our tradition of JSS participating in the Toronto Challenge – a city organized charity walk/run. JSS participation in the event was for a long time led by Tokugi Suyama until it was cancelled due to COVID. We want to take the opportunity to express our gratitude to Toku san and also let him know that we are carrying on with your legacy.

Strategic Directions

New JSS Strategic Plan completed in February 2021 with the following priority areas:

- Enhance financial sustainability : it is not news that JSS operations rely largely on donations and support from community members, and over years we have struggled to raise enough resources to continue our work. The board and staff were unanimous in identifying financial sustainability as the number one priority for the current JSS. Since the plan was developed, we have formalized the Fundraising committee with new board members and committee members with expressed interest and experience in the area, and in addition to the JSS Challenge, we have a few other initiatives that are being planned.
- Increase recognition in our community : on one hand, this is closely related to fundraising in that
 it is crucial to increase our appeal to potential donors. On the other hand, we have observed
 that there are so many in our community who don't know about us but who may benefit from
 our services and we will work harder to ensure we reach out to the community and raise
 awareness about our services, while also communicating better about the value of our work to

the potential donor base. The website renewal and further outreach work is some of the examples of progress in this area.

• Be the organization that the community can count on: JSS is a small organization but one with unique and essential mission to meet the needs of those in need and serve the Japanese community. During strategic planning discussions, it became clear that we need to develop our capacity to be more effective and responsive. Work in this area includes review of our services and need assessment, strengthening our organizational structure and collaboration between staff and the board.

Counsellor's Report 2020-2021

Takanori Kuge

- JSS staff started working remotely as of March 24, 2020
- The protocols for office use and The screening procedures for COVID 19 have been established. In-person counselling resumed under these protocols.
- In 2020 and 2021 to date, counselling and information service mostly have been provided remotely by **phone and the Internet (including video)**
- Counselling fee temporarily waived for the clients negatively affected by the COVID-19 pandemic
- The number of counselling & information service users in 2020 increased by 20% compared to 2019. (314 \Rightarrow 428)

* In the first half of 2021, the monthly average of the number of counselling service users has been increased by 34% compared to 2019. (54 \Rightarrow 73)

- The number of DV cases in 2020 increased by 27% compared to 2019. $(77 \Rightarrow 98)$
- JSS staff started working remotely as of March 24
- Counselling and information service have been provided remotely by **phone and the Internet** (including video)
- Counselling fee temporarily waived for the clients negatively affected by the COVID-19 pandemic
- The protocols for office use and The screening procedures for COVID 19 have been established. In-person counselling resumed under these protocols.
- The number of counselling service users has increased by **20%** after pandemic
